ADVERTISING RELEASES: The undersigned consents to the use of his/her name, pictures of him/herself and his/her car for publicity, advertising and endorsements both before and after the events and relinquish any rights to photos taken in connection with events and consents to the publication of such photos as the speedway desires.

ARBITRATION: Any controversy or claim arising out of or relating to this agreement, including any alleged breach, shall be settled in accordance with the rules of Star Speedway, Bobby Webber Jr. Racing, Action Racing North East and Little Webb’s, Inc.
